PIONEER is requesting continued temporarily abandon status on the Lorencito 15-11-34-67 well as it is not feasible to rework the well at this time due to current market conditions. A Form 5A for temporarily abandon status was submitted to the COGCC on 10/6/2015. A Mechanical Integrity Test dated 7/16/2015 has also been previously submitted. The Lorencito 15-11-34-67 well is closed to the atmosphere via a wellhead secured and shut-in by a valve as well as a bridge plug set at 1735'.
