Comment: **Rill erosion is occurring along the approximately 25-foot-tall cut-slopes on the well pad. Erosional downcutting is occurring within stormwater diversions in the northern and western portions of the project area. Erosional channels are forming on slopes downstream of a culvert, where concentrated flows exit the culvert. Access road ditches and a straw wattle along the access are full of sediment. A stormwater BMP in the southeastern corner of the well pad is in good condition. See photos.**

CA: **Well pad cut-slopes need to be stabilized. Revegetation is the best long-term stabilization measure. Stormwater diversion channels need BMPs to de-energize and filter stormwater flows diverted around the project area. Culvert needs to be cleaned and stormwater flows exiting the culvert near the well pad entrance need to be significantly de-energized to prevent further downcutting within the hillside. Sediment accumulation along the access needs to be cleaned and BMPs maintained.**

ACTION REQUIRED

ANY ACTION REQUIRED items listed on this report indicate that the oil and gas facility or the oil and gas operations listed on the report may be in violation of the rules and regulations of the Colorado Oil and Conservation Commission (“COGCC”) and corrective action is required.

There is reasonable cause to believe that a violation of the Oil and Gas Conservation Act, or of any rule, regulation, or order of the Commission, or of any permit issued by the Commission, has occurred. The Operator’s compliance with this Inspection Report is required to resolve these alleged violations. This document requires the Operator to timely respond to the COGCC and to comply with directives as listed by the **Corrective Action Deadline Date**. Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. (Please note that the COGCC's penalty authority was recently increased to a maximum of \$15,000 per day and penalties are no longer capped at a maximum of \$10,000 per violation.)
