Comments:

All debris and waste materials have been removed and all pits, cellars, and other bore holes have been backfilled. Previously disturbed areas were re-contoured, slopes were reduced and reseeded. A uniform vegetative cover density of 80% of the pre-disturbance levels has been achieved. Areas that were not used for production facilities, access roads, or other production operations have been stabilized with vegetation. Areas still in operational use, such as the well pad and access road areas, were stabilized with the use of permanent physical erosion reduction methods, and maintenance will be performed as needed to minimize dust and erosion to the extent practicable. The location will continue to be monitored for noxious weed infestations and stormwater BMPs.
