The tanks were manufactured by Conner Steel Products (now National Oilwell Varco) "Shale Green" per NOV (325-655-8225) after researching the Conner data base for tank SN 15948. We feel that the current color is within the Munsell soil color code and that the tanks are still well painted. When it comes time to repaint the tanks due to normal degradation a few years from now, we will repaint with to the requested color change.
