Remediation # 8697 -- Operator has installed a system of above ground skim tanks to replace earthen skim pits [#117631 & #109576]. All fluids have been removed from the skim pits and the pits have been covered with black plastic to limit fluid accumulation from rain and snowfall. Operator is currently reviewing several possible methods for soil disposal, soil remediation and hydrocarbon impact determination. Operator has met with COGCC staff to discuss soil disposal options. A meeting has been scheduled with the surface owner to discuss the pit closures. Reclamation will proceed on or before July 1, 2016.
