**COMMENTS**

Landowner of DWR Receipt 0013318B was contacted and verbal assent to sample obtained on 10/10/15. Arrangements made to meet, receive signed access to sample, and sample water well were made on 10/10/15 for 10/12/15. Landowner cancelled meeting with intention to re-schedule for 10/14/15. Multiple calls on 10/14/15 were not answered. Continuing attempts to re-establish contact and obtain sample.

Landowner of DWR Receipt 3661394 has a disconnected phone line. Attempts to visit location to deliver access request were unsuccessful as no structures were found at mailing address.

During pre-drill sampling, the location of the production well was mis-identified as being in SWSE Section 25. A water well owned by landowner of DWR Receipt # 0013318B was the only water well identified within 1/2 mile of the original location and was sampled and submitted as sample ID 539427. During the preparation for post-completion sampling, the incorrect location was identified. The sampled location was not within 1/2 mile of the production well. The two water wells referenced above are within 1/2 mile of the actual drill location. Unsuccessful attempts began to contact the landowners and obtain access to sample.
