The well will be drilled to a KOP at 5272' TVD. A curve will be built to land the 7" casing in the Niobrara at 5793' TVD. The lateral will be drilled with a 6" bit to TD at 13426 MD. A 4-1/2" liner will be run in the lateral and cemented for completion.
