- 6) Bleed off bradenhead, unland casing
- 7) Trip in 1 1/4" tubing down annular w/ mule shoe to +/- 1650', condition hole.
- 8) RU cement crew, pump 550 sxs 15.8ppg "G" neat cement bringing cement to surface (25% excess assumed)
- 9) POOH with 1 1/4" tubing, land casing.
- 10) SI well overnight, run CBL recording new cement depths
- 11) Exchange wellhead equipment for 5k psi rating. Remove plug
- 12) RDMO Workover rig, pump & tank.
