Request an Exemption from Rule 325c.1 for the Lyons, L. Satanka, Wolfcamp, Amazon, Council Grove, Admire, Virgil, Missouri, Fountain, Des Moines & Atoka Formations for the NGL C10A (API # 05-123-41202) well due to its proximity to the NGL C10 (API # 05-123-40772) and its high water TDS analysis results. The C10 is a vertical well and the C10A is directional with the injection formations separated by aprx. 3984'. The NGL C10 well acquired water samples from the formations as listed above and no samples obtained had a TDS less than 13,000 mg/L. A Correlation spreadsheet is attached showing the details of the TDS values in the NGL C10 and correlated to the same formations of the NGL C10A.
