Dear Mr. Hair:

Angus Natural Resources, LLC (“Angus”) plans to drill the above captioned well on your land in Cheyenne County Colorado. In accordance with Rule 305 of the Colorado Oil and Gas Conservation Commission (“COGCC”), this letter serves as a 30 day notice from Angus of its intention to drill an oil & gas well on the above referenced location. Drilling operations are expected to begin within the next 45 days pending approval of required permits & title and rig availability. Included with this letter is a brochure prepared by the COGCC entitled: “Oil and Gas Well Notification, Consultation and Reclamation Rules” as part of information provided to surface owners.

COGCC regulations provide that the surface owner may waive the 30 day notice requirement, and as part of Rule 306 of the COGCC, a written notice is also required from the surface owner to request or waive a consultation meeting with Angus regarding the location of the above referenced well and related equipment.

Enclosed to this letter is a waiver and request for consultation form. Please read and complete the form declaring your decision regarding the 30 day notice and consultation meeting as required by Rule 305 and 306 of the COGCC. Please return the fully executed form in the postage-paid envelope included with this letter.

As the surface owner, Rule 305 of the COGCC states that it is your responsibility to notify any tenant farmer, lessee, or any other party that may own or have an interest in any crops or surface improvements that could be affected by the proposed drilling operations.
