- 1) MIRU Workover rig, pump & tank.
- 2) Control well with kill fluid
- 3) POOH 2 3/8" tubing
- 4) RIH w/ Bit & Scraper. Tag fill if any. Clean out to PBTD (tally in). TOOH
- 5) RIH w/RBP. Set RBP @ +/-6850', spot 2 sx of sand on top of RBP. Test RBP 2,000psi. TOOH
- 6) Bleed off bradenhead, unland casing
- 7) Trip in 1 1/4" tubing down annular w/ mule shoe to +/- 1585', condition hole.
- 8) RU cement crew, pump 650 sxs 15.8ppg "G" neat cement bringing cement to surface (25% excess assumed)
- 9) POOH with 1 1/4" tubing, land casing.
- 10) SI well overnight, run CBL recording new cement depths
- 11) Leave plug in hole for upcoming fracture stimulation
- 12) RDMO Workover rig, pump & tank.
