COMMENTS:

The increase in the Bradenhead pressure was a result of thermal expansion of the 7" casing string due to increased fluid temperature in the wellbore. The wellbore fluids had increased in temperature due to coil tubing operations to drill out 3000' of cement left inside the 4.5" casing as a result of lateral cementing complications during drilling. The high alarm was noted towards the end of the 32.5 hour coil drilling operations where the same fluid had been circulated through the well and BHA multiple times increasing in temperature.
