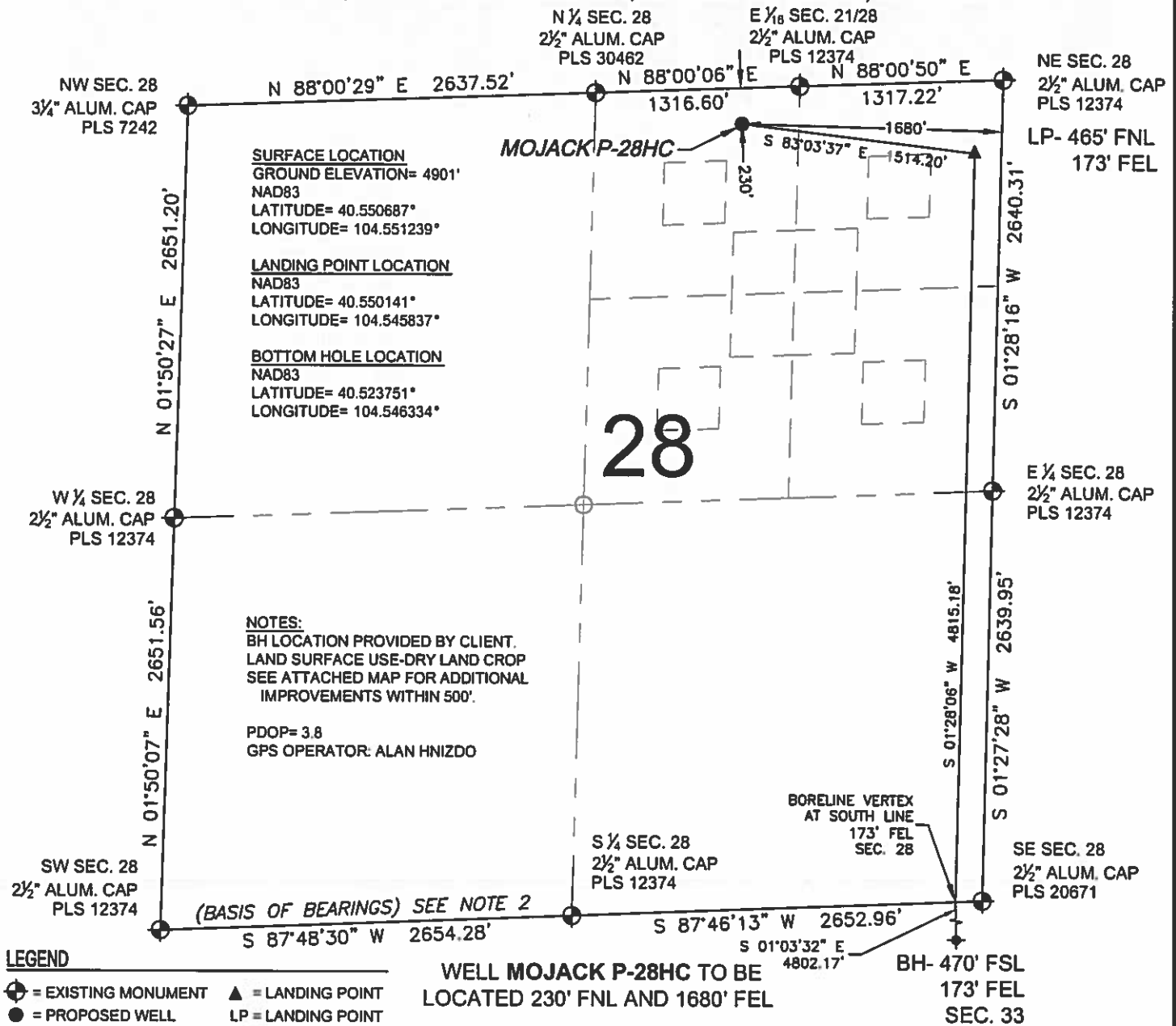


# WELL LOCATION CERTIFICATE: MOJACK P-28HC

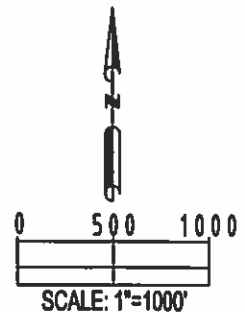
