Comments: There are no surface water features within 4000' of the edge of the disturbed area of the location, so no Hydrology map is required. The map shows a Fosset gulch head cut, which does not hold water unless it rains. It is a dry creek. The nearest water well is at the Candelaria's household which is over a mile away. The multi-well plan is not needed for this well, because the FGU 16U#1 well was never completed.
