Flowline from well head to separator to tanks will be buried 2 inch steel. One buried 2-4 inch steel water pipeline and one buried 3-6 inch steel gas pipeline will be installed on pad and tied into existing gathering pipelines located off the well pad. A 12 inch steel gas pipeline will extend from the pig launcher located on the well pad and tie into the existing gathering pipelines located off the well pad. Temporary 12 inch to 24 inch poly pipeline may be used on the surface at times to bring completion water to location from the McIntyre Flowback Pits 3 and 4. Flowback will return to the pits via this temporary pipeline system as well. These temporary poly pipelines would likely be located on the pad and along the access road.

Comments: This location is being amended to include 3 additional wells: Federal 12-89-7 #2, Federal 12-89-7 #3, and Federal 12-89-7 #4. A new construction layout drawing has been revised to show all four wells and has been attached. No new disturbance beyond what has been previously permitted and approved (Form 2A doc# 400819007) will be required to accommodate the additional wells. There have been no changes to the surrounding land use. The well site has not been built. We will apply the BMPs as included on the previously approved Form 2A, as well as those attached to this amended Form 2A. Distances to cultural features from the well head have been updated to reflect the current layout of the wells on the pad.
