E½E½ of Section 11, Township 6 North, Range 65 West  
W½W½ of Section 12, Township 6 North, Range 65 West  
Containing 360.00 acres, more or less

Bayswater is not the only owner within the Proposed Spacing Unit and has provided notice to the remaining owners, as required by COGCC Rule 318A.e.(6). 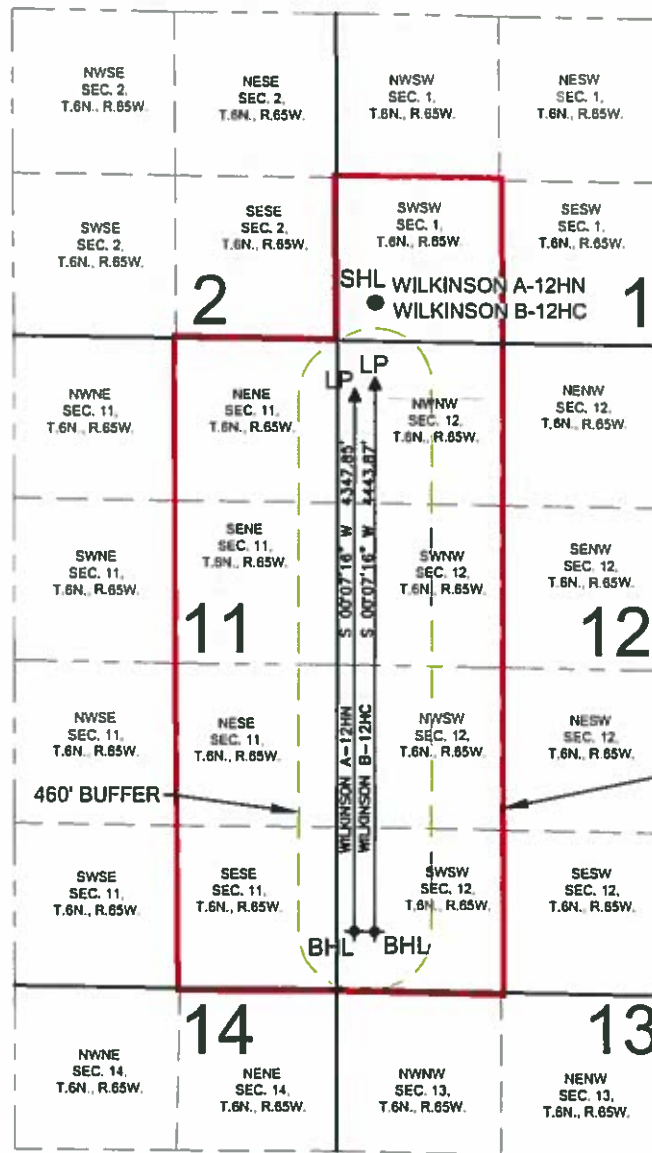

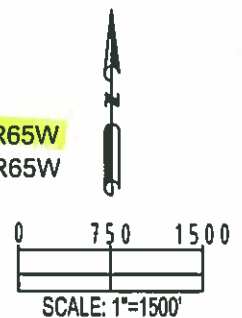
**WILKINSON 1-P PAD**
