The production liner will be hung off inside of the 7" casing string. 7 Well Pad includes, Gutttersen State DD08-785, DD08-780, DD17-775, DD17-770, DD17-755, DD17-760 And DD17-765. Noble Energy shall isolate the Upper Pierre Aquifer from the Fox Hills Aquifer with surface casing and cement and utilize intermediate casing and cement to ensure isolation from below. Nearest well Gutttersen state DD8-13, 123-22911. Nearest offset operated Gutttersen 8Q-201, 123-39367 (PDC). Distances have been calculated from footages from the COGCC scout card.
