Comments

This well permit is being refilled due to expiration. This well pad has not been constructed, however, the access road going through the pad and the existing pipeline infrastructure was constructed in April 2012 to access the MDP 26 pad. No wells have been drilled on the location. There will be no changes to the previously approved APD including the proposed SHL, BHL, drilling plan, casing and cement program, or mineral lease information. The uploaded well location plat and directional remain the same. The distance to nearest well completed in the same formation / permitted or existing well penetrating objective formation was measured to the producing Federal 22A-33-691.

All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
