



BER 44-15 is to be located at a point 301' from the SOUTH line and 446' from the EAST line, measured at right angles, of the SE Quarter of Section 15, Township 1 South, Range 44 West of the Sixth Principal Meridian, Yuma County, Colorado.

Latitude, Longitude, and Elevation are derived from RTK-GPS observations, and are based on published coordinates for NGS Station U385 MP234.73, located approximately 2.1 miles east of the proposed well location.


Distances shown hereon are at ground level and are field-measured.
