**Comments:**

Remediation # 8700 -- Operator has installed an above ground skim tank and is no longer using earthen skim pits. A preliminary soil excavation was performed in July 2015 and 433 tons of impacted soil was hauled to Buffalo Ridge facility. An additional 500 tons (est.) of soil was excavated in October 2015 and is stockpiled on location. Operator is currently reviewing several alternative methods of soil disposal, soil remediation and hydrocarbon impact determination. Operator has met with COGCC staff to discuss these alternative disposal methods. Operator will commence final reclamation on or before July 2016.
