Remediation # 8701 -- Operator has installed an above ground skim tank to replace the earthen skim pits [#117549 & #119836]. All fluids were removed from skim pits and the pits have been covered with black plastic to limit fluid accumulation due to rain or snowfall. Operator is currently reviewing several possible methods of soil disposal, soil remediation and hydrocarbon impact determination. Operator has met with COGCC to discuss disposal and remediation options. Reclamation will proceed on or before Septmeber 1, 2016.
