Comments:

Please be more specific about the information you are sending:

- I couldn't find in the supplemental information stating that the attached lab results was a confirmation sample.
- The (confirmation?) sample location was not specified in the figure.
- The Facility ID provided in the supplemental was (again) a well ID number, instead of the Location ID #. The result is that the supplemental will be automatically linked to a well API and not to the Site Location ID, making it more difficult to find information in the future.

The supplemental e-form 19 requesting closure of the spill report cannot be approved as presented.

Please re-submit the supplemental with all the required information by Friday, Dec 04, 2015.

Please read Rules 906, 909, and 910.

Rule 906 b. states: "In addition to the Initial Report to the Director, the Operator shall make a supplemental report on Form 19 not more than 10 calendar days after the spill/release is discovered that includes an 8 1/2 x 11 inch topographic map showing the governmental section and location of the spill or an aerial photograph showing the location of the spill; all pertinent information about the spill/release known to the Operator that has not been reported previously; and information relating to the initial mitigation, site investigation, and remediation measures"

Black Diamond has incurring in the following violations:

- 1) The supplemental should have been submitted within 10 days of the spill. It is being submitted a year later;
- 2) The supplemental should include maps, figures indicating the location and extent of the impact. No maps, figures have been included.
- 3) Either the first or a second supplemental should be submitted providing information about remediation activities and confirmation samples. No lab results have been submitted.

Notes:

- 1) Closure cannot be granted until confirmation samples are taken and analytical results demonstrate that impacted area has been remediated (Samples must be analyzed for all Table 910-1 parameters) analytical results within Table 910-1).
- 2) The Location ID provided (297747) is a well ID, not a Location ID. Please use the Location ID (#334457)
