



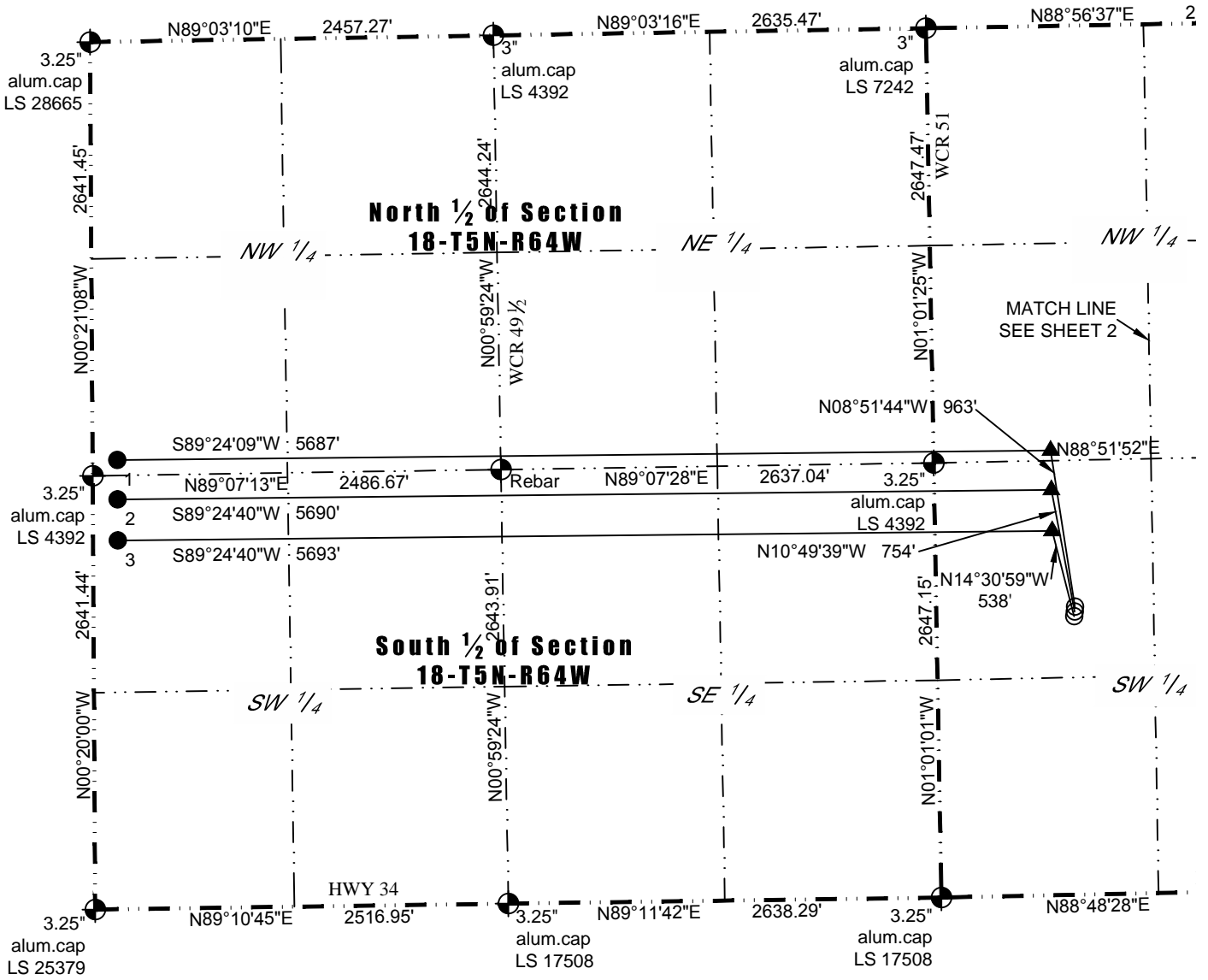

(WEST LATERALS)

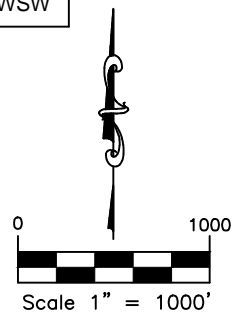

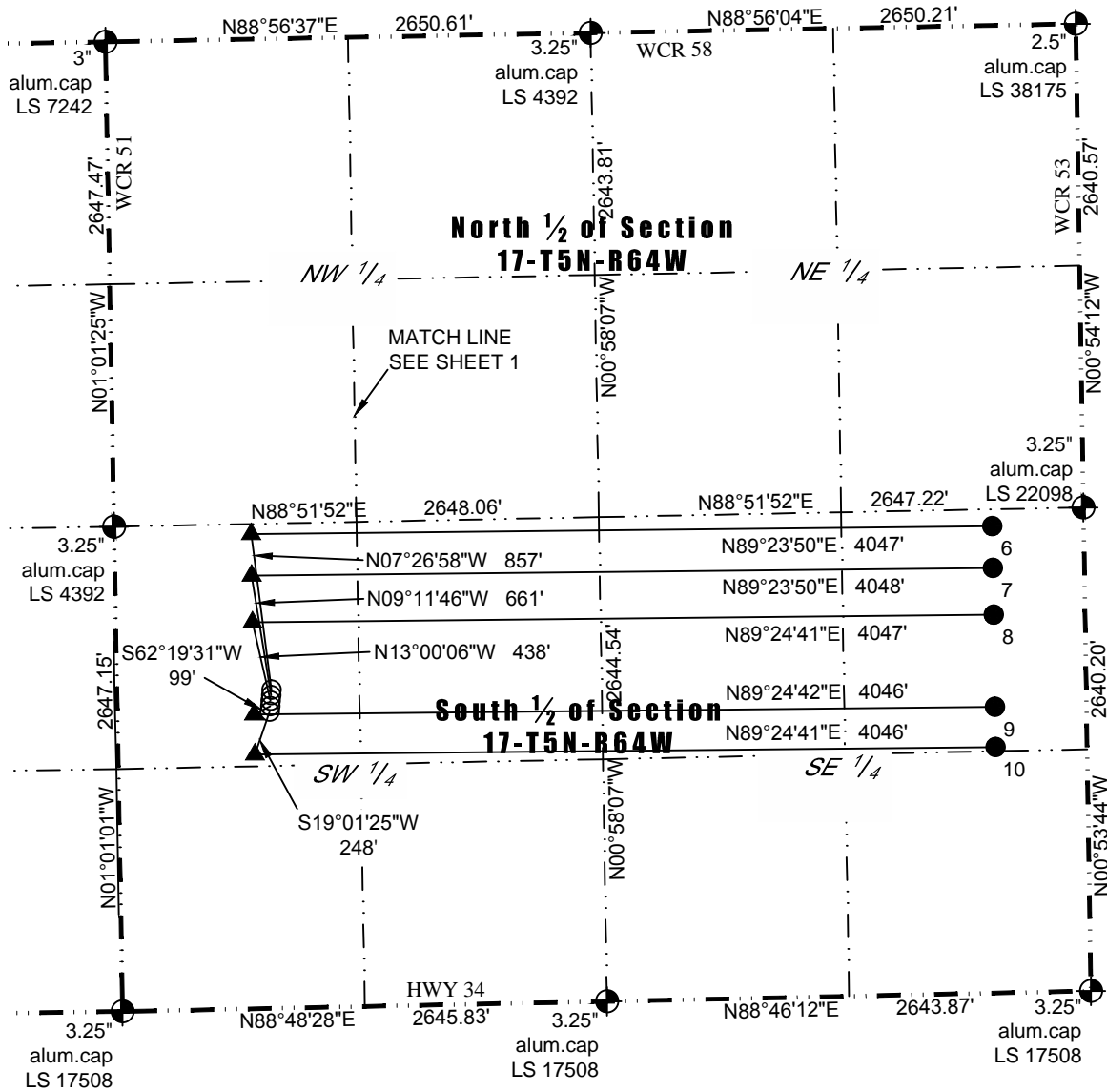

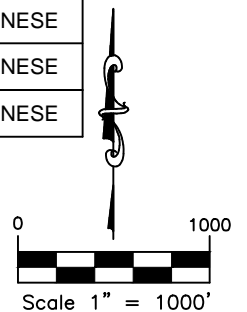
