COMMENTS:

On June 23, 2015, a gas sample was collected from the Battlement Mesa 26-33C well and submitted for laboratory analysis of tritium. Laboratory results indicated that the sample was above the Sampling and Analysis Plan (SAP) screening level for tritium in gas, but below the SAP action level. In order to verify this result, another sample was collected from this well the week of October 19, 2015. We do not anticipate results to be reported for this sampling event until late December 2015. In order to give us time to accurately review all of the data presented, Caerus requests that the COGCC approve an extension for the second quarter 2015 monitoring report until February 29, 2016. Stan Spencer of the COGCC approved the extension via electronic mail and requested that we formally request this extension through a Form 4. The email with his approval is attached to this form.
