This Sundry Notice is submitted to inform the COG of the of a change in the construction of the bore hole in the referenced well. This reconstruction is to bring the bore hole into compliance with the requirements of the COGCC rules for "current standards" for proof of cement as required by the DJ Basin Horizontal Offest Policy (options 4) as it relates to the pending application of Kerr Mcgee's Land Federal 30C-29HZ (API # 05-123-42401). The well is to be perforated at 6950' and a 200' fill will be pumped behind the casing.

The rop of the cement will be confirmed with another cement bond log.

By raising the cement 200' above 6950' there will be more that the required 200' of cement above the Niobrara. With this new cement and the Stage Tool at 1374' with good cement to 485' the Sussex will be isolated.

A CBL will be run to verify "top" of the newly placed cement.

After cement has cured for a day or two the casing will be tested to 600 psi at the surface.

Assuming every thing goes as planned, TOP will provide proof of cement for this well.

Replaced well head with 5,000 lbs. well head.
