In response to Inspection No. 674700948, for location #335593, and in lieu of the requested Form 42, Encana Oil and Gas (USA) Inc. has reviewed the corrective action: location is used for storage of equipment and supplies - remove unneeded equipment and supplies, and determined that the area not used to support production operations will be permitted as an oil & gas storage facility. Encana Oil and Gas (USA) Inc. has begun coordinating site surveys for the area in questions, and will proceed with the survey, drafting, and permit requirements necessary to permit the location as an oil & gas facility in Garfield County.

Encana Oil and Gas (USA) Inc. has also reviewed the corrective action item "Control sloughing of cut slope wall" and will complete the work as soon as practicable while following best management practices described in our Wildlife Mitigation Plan, which is a formal agreement with Colorado Parks and Wildlife and provides guidelines to minimize the possibility of disturbing wildlife. Specifically, we will minimize our surface disturbance, recontoured slopes where possible, and stabilize all areas not in use with vegetation, mulch, gravel or other methods, between July 31 and December 15.
