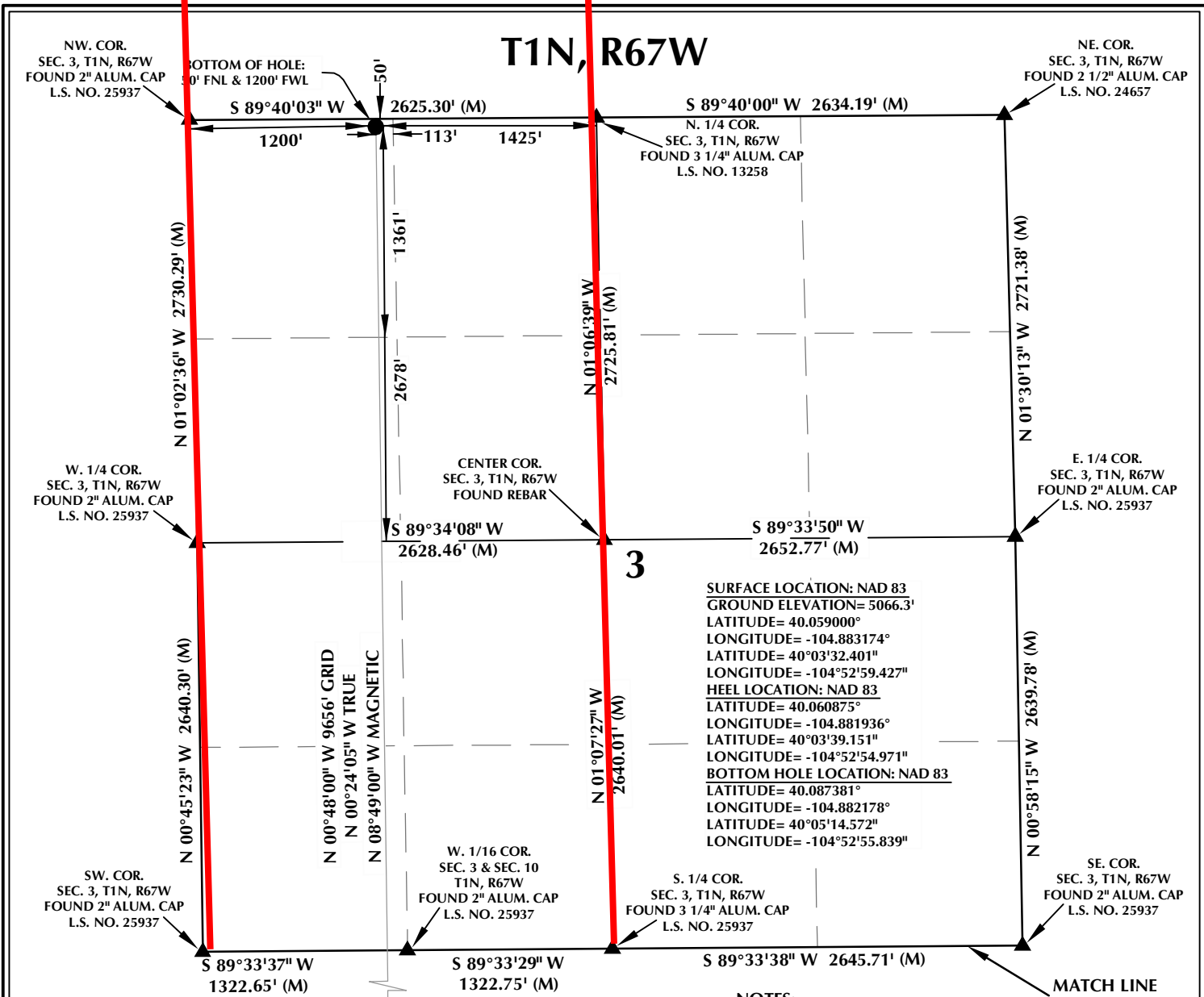

PROPOSED SPACING UNIT



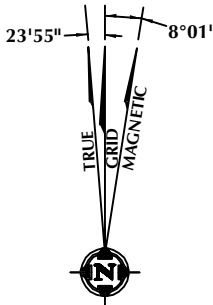
