The access road to the location did not appear to be present before construction of the location and was not reclaimed. The access road will need to be reclaimed within 12 months after plugging the well (3/13/2016). Soils are likely compacted along the access road which will require decompaction to a depth of 18 inches.	CostaR	12/04/2015
