COMMENTS:

We are asking for a variance on the Vaneta 01-32D (Salt Water Injection Well) with regards to the 600 Series Rules. Specifically, we are requesting a waiver to Rule 605.a.(8) relating to the distance from the wellhead to the produced water storage tanks and generally for permission to locate the injection pump close to the wellhead.

We are requesting this variance due to the inclement winter weather conditions at the location.

It is necessary to house all the equipment in an insulated building to prevent freezing. Locating the produced water tanks close to the injection wellhead limits the amount of pipe required and thus reduces the amount of equipment that needs to be kept from freezing. The insulated building that contains the injection pump and other ancillary equipment is explosion proof. The injection pump is powered by an explosion proof electric motor. All switches and lights inside the building are also explosion proof.
