Proposed Procedure:

1. MIRU pulling unit.
2. Rig up wireline company. Establish free point of 3 1/2" casing. (The current CBL indicates some bonding above 6475' but was not run above 6350'. Calculated top of cement is 6200'.)
3. TIH with casing cutter. Cut off 3 1/2" casing at 6100'. Pull 3 1/2" casing.
4. TIH with tubing to 6150'. RU cementers. Mix and pump 50 sxs of 15.8#/gal CI G cement.
5. Reset tubing at 450'. Mix and pump 170 sxs of 15.8#/gal CI G cement. Cement should circulate to surface.
6. Cut surface casing 6' below ground level and weld on cap.

	Note changes to plugging procedure: 1) Provide 48 hour notice of plugging MIRU via electronic Form 42. 2) Add CIBP and 2 sx of cmt at 6884, to provide Niobrara isolation. 3) For 450' plug: pump plug and displace. If surface casing plug is not circulated to surface then tag plug – must be 117' or shallower and provide 10 sx plug at the surface. Leave at least 100' of cement in the casing for each plug. 4) Properly abandon flowlines as per Rule 1103. File electronic Form 42 once abandonment complete.
