COMMENTS:

Per conversation with Dirk Sutphin @ COGCC, XTO Energy would like to request an exemption from Rule 608e Bradenhead Testing on this well. Since the previous operators drilled and completed the well with only one (1) string of casing, there is no bradenhead annulus to test. Without at least two (2) casing strings, this well has no annular space that meets the definition of Bradenhead in the 100 Series - Definitions. As suggested by Mr. Sutphin, we request this well be exempted from the 608.e testing requirement on this basis. Attached is the current WBD & original well completion report (doc #01341955) showing that only one string of casing was run and cemented in the well.
