Hill 6-6 Remediation (COGCC Remediation Number 9285)

Whiting Oil and Gas Corporation (Whiting) is requesting approval to backfill the pit excavated at the Hill 6-6, utilizing the overburden stockpile soil for the top layer of backfill material. The analytical data, as summarized in the attached Tables, indicate that the proposed backfill materials meet the applicable Table 910-1 limits, with appropriate consideration given to the background soil analytical data. The analytical data also indicate that the excavation sidewalls and bottom also meet the applicable Table 910-1 limits. Laboratory analyses were conducted by the ALS Laboratories in Kelso, Washington and Holland, Michigan, based on laboratory availability.

Whiting will plan to submit a final report to the COGCC following site backfill activities, and seek to close out the remediation project at that time.
