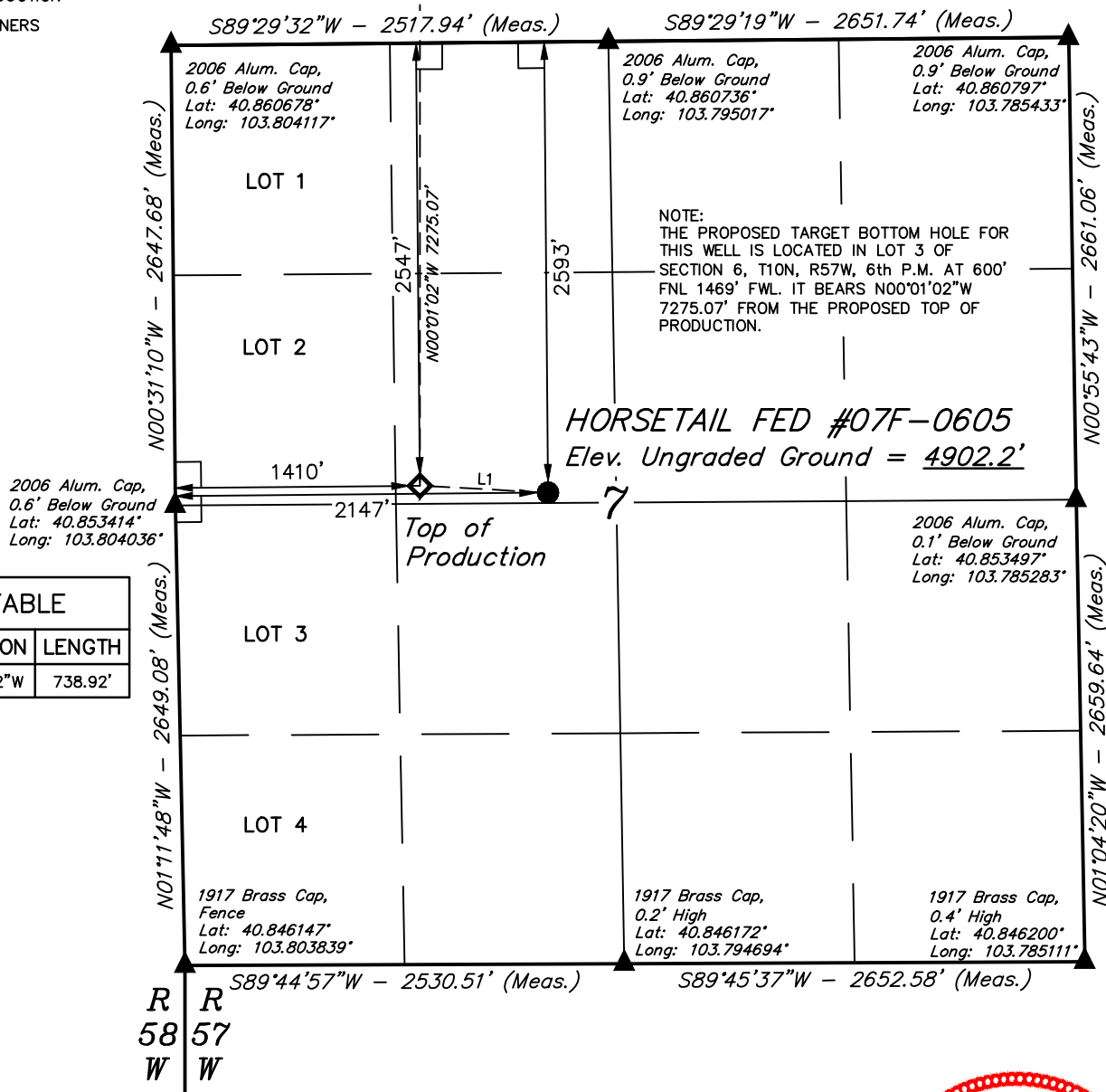

## WELL LOCATION PLAT

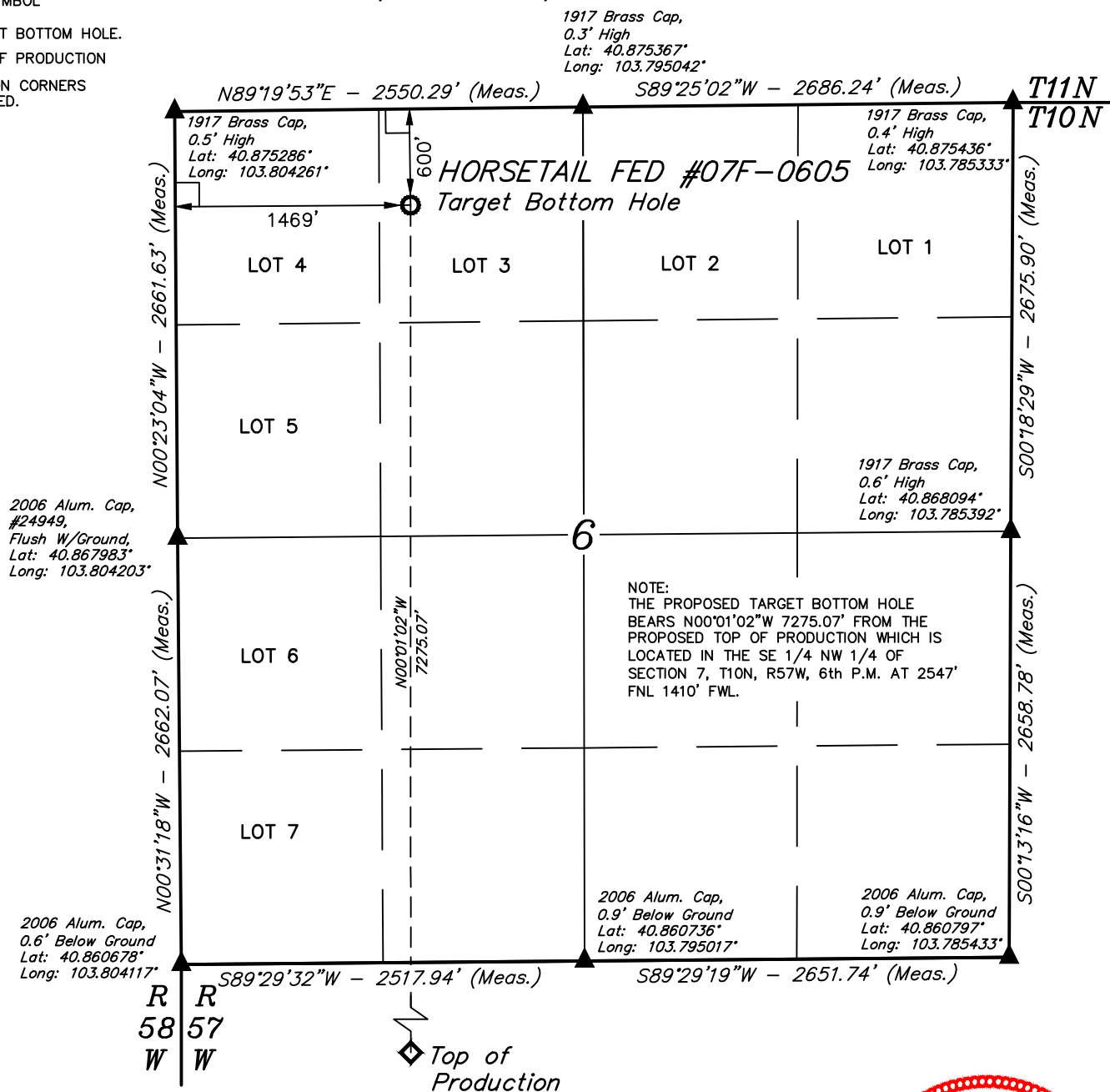

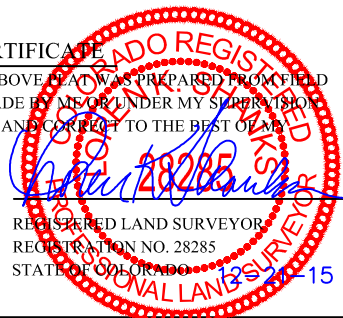
