This is a revised OGLA. The original requested surface disturbance will not change. SandRidge Exploration & Production LLC is adding one well with additional facilities. Distance to nearest Above Ground Utility was measured to the existing Hebron 5-18H which was permitted (2008) and drilled prior to the 200' setback rule change. All new wells conform to the 200' safety setback.
