Well is TA'd using a 4 1/16" 10,000# frac valve with a 4 1/16" night cap flange bolted to the top of the frac valve to provide additional security. There is one producing gas well and 13 cased wells waiting on completion. This well has future potential as a gas well when market conditions improve.
