## COMMENTS:

This sundry notice is associated with Remediation Project #8927 and is for Alex Fischer. OXY USA WTP LP (Oxy) is providing this sundry notice as a status update for the Pond 13 East remediation and reconstruction project, reference document #2314004. Due to delayed permit approvals, Oxy has postponed liner removal and characterization of the pit until favorable weather conditions allow complete characterization, remediation if required, and reconstruction of the pit to meet Centralized E&P Waste Management Facility (CEPWMF) construction requirements. Outlined below please find an estimated construction schedule for 2016:

May 14 - begin removing the liquids present in the pit;

June 1 - begin removing the solids found at the bottom of the pit;

June 21 - conduct liner inspection to identify any holes in the liner and to aid in the characterization of soil below the pit;

July 1 - begin removing the liner for offsite disposal;

July 5 - assess below liner soil impacts and characterize the pit bottom for COGCC Table 910-1 standards;

July 7 - assuming impacts are identified, begin excavation and removal of impacted soil to meet COGCC requirements;

August 1 - begin reconstruction of the pit to meet construction plans as a CEPWMF;

August 31 - complete as-built survey of site prior to liner installation;

September 3 - begin installation of the liner system;

September 24 - conduct hydrotest for the facility;

September 28 - begin operation of the facility as a CEPWMF.
