Comments

Top of Production Zone, as discussed with Christy Ng, is the Top of Niobrara and not the Landing Point. The distance from the proposed wellbore to the nearest completed portion of offset wellbore permitted or completed in the same formation and the nearest existing or permitted wellbore belonging to another operator were both taken from the Hebron 1-18H, API No. 05-057-06501, currently owned and operated by EE3 LLC. There are multiple leases that cover this location. The horizontal wellbore crosses this lease line and conforms to the Drilling and Spacing Unit and its setbacks. This permit is being submitted with a revised Oil and Gas Location Assessment. SandRidge will be adding additional wells and facilities to this location.

1	Drilling/Completion Operations	One of the first wells drilled on the pad will be logged with open-hole Resistivity Log and Gamma Ray Log from the kick-off point into the surface casing. All wells on the pad will have a cement bond log with gamma-ray run on production casing (or on intermediate casing if production liner is run) into the surface casing. The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
2	Drilling/Completion Operations	Anti-Collision: Sandridge will perform an anti-collision evaluation of all active (producing, shut in, or temporarily abandoned) offset wellbores that have the potential of being within 150 feet of a proposed well prior to drilling operations for the proposed well. Notice will be given to all offset operators within 150 feet prior to drilling.
