Pipeline construction will not block or change the natural course of any drainage. The pipeline will be buried wherever possible. The pipeline will be buried a minimum of 30" below the surface at all locations. Pipeline trenches shall be maintained in order to correct settlement and erosion. The pipelines will be a 8" or 6" production and 6" or 4" test. All lines will be welded steel.
