OPERATOR COMMENTS AND SUBMITTAL

Comments

The distance from the completed portion of the proposed wellbore to nearest wellbore permitted or completed in the same formation was measured to the Mutual 7-17H, API No. 05-057-06472. The distance from the proposed wellbore to nearest existing or permitted wellbore belonging to another operator was taken from the Trownsell 7-80 8-1, API No. 05-057-06440, currently owned and operated by Red Willow Production LLC. PLEASE NOTE: The distance between the proposed well and the Mutual 7-17H, operated by EE3 LLC is 355 feet. SandRidge has acquired EE3's assets in this area and a Form 10 has been filed but not yet approved so the Trownsell 7-80 8-1 was listed as the nearest well belonging to another operator. The horizontal wellbore conforms to the Drilling and Spacing Unit and its setbacks. The top of production zone, as discussed with Christy Ng, is the top of the Niobrara and not the landing point.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log.
