- Road access to location – Access road to the east (existing access)
- Sound mitigation – sound walls will be constructed
- Light mitigation – Lighting will be provided during drilling and completion operations to ensure worker safety and compliance with all regulations. To the extent practicable, site lighting shall be directed downward and inward and shielded so as to avoid glare on public roads and building units within one thousand (1000) feet. A soundwall will also provide light mitigation.
- Location of production facility / aesthetics – Will review need for additional screening (trees) after drilling and completion operations commence.
- Drill timing – Advised of average drill time and estimated number of days that the drilling rig would be on location.
