**This Warning Letter is to inform you that the oil and gas facility or the oil and gas operations listed above may be in violation of the rules and regulations of the Colorado Oil and Conservation Commission ("COGCC") and correction action is required.**

There is reasonable cause to believe that a violation of the Oil and Gas Conservation Act, or of a rule, regulation, or order of the Commission, or of a permit issued by the Commission, has occurred. The Operator's compliance with this Warning Letter is required to resolve these alleged violations. This document requires the Operator to timely respond to the COGCC and to comply with directives as listed by the **Corrective Action Deadline Date**. Failure to do so will result in the issuance of a Notice of Alleged Violation and initiation of enforcement proceedings in which COGCC will seek monetary penalties for the alleged violations pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. The COGCC requires Alamosa Drilling Inc ("Operator") to implement corrective action(s) for the conditions identified below:

Rule 309 of the "Colorado Rules and Regulations, Rules of Practice and Procedure and Oil and Gas Conservation Act" states: "Each producer or operator of an oil and gas well shall file with the

Submit Form 7 Monthly Reports of Operations for all wells/formations listed on the attached Delinquent Report.

**Corrective Action Deadline Date: February 12, 2016**

**Failure to Comply with this Warning Letter:**

If Operator fails to perform the required corrective action(s), COGCC will issue a Notice of Alleged Violation and seek penalties pursuant to § 34-60-121, C.R.S. and Rule 523, COGCC Rules of Practice and Procedure, 2 CCR 404-1. (Please note that the COGCC's penalty authority was recently increased to a maximum of \$15,000 per day and penalties are no longer capped at a maximum of \$10,000 per violation.)
