5	Construction	<p>Containment berms shall be constructed and designed to prevent leakage and resist degradation from erosion or routine operation.</p> <p>All equipment will be anchored to the extent necessary to resist flotation, collapse, lateral movement, or subsidence.</p> <p>Berm Construction- Tank berms shall be constructed using engineered technology designed to contain 150% of the capacity of the largest tank.</p> <p>KPK will install an engineered containment system around the tank battery. The containment system is constructed of a perimeter of earthen berms that are lined with a 30 mil HDPE liner, that per manufacturer's specifications, is overlapped by 2'. This liner is puncture resistant under exposure to UV rays, weather extremes, and chemicals commonly encountered in oil and natural gas production, and provides seamless protection. The liner will be covered with 1/2"-3" gravel as described in drawing attached. In addition to the engineered containment system, KPK will install bollards on the upstream end of the tank battery as an added safety measure. The bollards will provide added protection to the tank battery in the event of a flood in which objects and debris may be floating downstream. The bollards will be constructed of steel pipe filled with concrete and will protect the containment system from being struck and compromised by floating debris.</p> <p>All berms will be visually checked periodically to ensure proper working condition.</p>
