Steve,

I am able to view that copy and will add it to the spill file. A couple notes about analytical requirements:

1. Colorado does not accept TCLP for metals. Total Metals must be run when required for remediation. However, metals are not usually required for produced water and oil/condensate spills. Check before analyzing metals, because Table 910-1 lists a health based standard for arsenic that is lower than natural background standards. Site-specific background samples are usually necessary when analyzing for metals.
2. Produced water spills require analysis for BTEX in addition to TPH-GRO and TPH-DRO.
3. COGCC generally does not accept composite samples for confirmation soil sampling at spills. Discreet samples should be collected from the area(s) most likely to have been impacted.
4. The electrical conductivity for sample A1-A4 composite exceeds the Table 910-1 Standard of 4 mmhos/cm. Since electrical conductivity is a reclamation standard, and this is an active site with the spill confined to the location, the spill could be conditionally closed with this result.

To resolve this spill (Spill ID 444158), please collect additional soil samples from the spill area and analyze them for BTEX. Submit the analytical report, along with a site figure illustrating the sample locations on a Supplemental Form 19 for this Spill Report.

For the more recent spill at this site that left the location (Spill ID 444492), please be sure to collect soil samples from the area that was impacted offsite. Analyze all the samples for BTEX, TPH-GRO, TPH-DRO, ec, pH and SAR.
