Couey 24-12 Casing Repair

Procedures:

1 Hold a pre-job safety meeting. Discuss all aspects of the procedure with any involved personnel. Identify and address any safety concerns before the job begins.

2 MIRU pulling unit. Kill well with produced water.

3 ND wellhead, NU BOP.

4 POOH with tubing. Scope out of hole, and visually inspect all tubing for corrosion, scale, and holes. Replace joints as needed.

5 Pick up RBP, RIH and set above top perf.

6 Pressure test casing

7 If failed pressure test, pick up packer and locate hole.

Echometer shows hole ~3,150'.

8 Run MIT/MTT 40 arm caliper log to determine condition of casing. Contact engineer regarding extent of damage.

9 RIH with bit and scrapper where patch is to be set.

10 RIH with 3.8" X-span casing patch on wireline, set and secure patch.

11 RIH with completion as follows:

- Wireline Re-entry @ 7,180' – Top of stage 2, approximately 65% into perms
- Seat nipple
- Approximately 228 JTS 2-3/8" 4.7# L-80 tubing

12 Update Wellview WBD with current tubing configuration.

13 ND BOP, NU wellhead.

14 RDMO Workover rig.

15 Place well back on production.
