#### COMMENTS:

Per a review of the wellbores, it was determined by SandRidge that the planned completed portion of the lateral between the referenced well and the Hebron 2-07H is greater than 800 feet and that the fracture orientation will be in an east/west direction and not north/south. SandRidge believes there is zero chance of communication between the two (2) wellbores as the perf intervals will be greater than 600 feet. SandRidge respectfully requests the mitigation measures agreed to by EE3 be removed from this permit.

A gel plug will be pumped below and a balanced cement plug placed from this depth to 300' above the 9-5/8" casing shoe." THIS REMEDIAL CEMENT PLAN IS CONSISTENT WITH COGCC'S INTERIM STATEWIDE HORIZONTAL OFFSET POLICY MITIGATION OPTION NO. 1.</p> <p>The current operator (SandRidge Exploration &amp; Production LLC) reached an agreement with COGCC Engineering staff on 1/14/2016 that the mitigation proposed by EE3 LLC is not necessary, per Interim Statewide Horizontal Offset Policy Mitigation Option No. 4 (agreement that additional mitigation is unnecessary under the circumstances).
