#### COMMENTS:

On 12/21/15 the decision was made to pull the Halliburton frac crew off of the Anschutz State 5-62-22\_23 NWSW pad to allow for operational remediation of three wells on the pad, which had started on 11/29/2015. Relocation of the frac crew allowed us to move in a workover rig to replace the tieback string on the 3225C2, and to simultaneously rig up coiled tubing to perforate screened out stages on the 4841C2 and 4841B2. On 1/27/2016, wells will be ready to continue frac operations, as BBC will be returning to the pad to finish completing the pad. Form 42's providing 48 hour notice to frac start were submitted on 1/25/2016.
