COMMENTS:

This well was shut-in in December 2013. Currently Black Hills believes that the Debeque 1-18 has sand over the perforations and tubing. We would like to perform maintenance on this well in April/May timeframe. We would like an extension on the MIT requirement (Rule 326.b.(1)) so that we may MIT and also do well maintenance at the same time. In April, we would like to pull tubing, set bridge plug and perform an MIT. Then retrieve bridge plug and continue to clean out the hole with workover and workstring. Then run back in with inspected tubing. Current weather and road conditions do not allow for a workover to get to location safely and we would like an extension into April/May when the weather will be cooperative, and the location is safe and accessible.
