We have drilled into a large fault and we have over 200' of the Sharon Springs exposed. We tripped out of the hole last night to change out BHA and we are having trouble getting back through the fault. We have gotten stuck multiple times trying to get back to bottom. We plan to open hole sidetrack in the lateral to avoid the Sharon Springs and drill the well to TD.
