#### COMMENTS:

Black Hills Plateau Production, LLC (Black Hills) currently has a stockpile of soil (soils) which Black Hills would like to re-incorporate into the Horseshoe Canyon #3 well pad. Samples were collected from the stockpile and analyzed for constituents outlined in Table 910-1 of the COGCC 900 series rules to determine if there is any concern of impacts. All of the constituents met Table 910-1 criteria with the exception of arsenic. Background sampling conducted in an undisturbed area around the location revealed an elevated concentration for arsenic of 6.5mg/Kg. Arsenic concentration derived from composite sampling of the stockpiled soil resulted in an arsenic concentration of 4.3mg/Kg. In this case, Black Hills would like to request an allowance for the arsenic exceedance on the grounds that the stockpiled soil concentrations of arsenic are below that of background concentrations for the area. This request is in accordance with footnote 1 of Table 910-1 which indicates consideration will be given to background levels in native soils and groundwater.
