7	Construction	RULE 604.c.E: This will be a 2 well pad. Only the 2 WH will be on the location, no tanks or equipment. Both wells will be connected via buried pipeline to the already permitted NGL MAJOR FACILITY C2 as noted on the Related Remote Locations tab.
8	Construction	RULE 604.c.M: Unless otherwise requested by the Surface Owner, well sites constructed within Designated Setback Locations, shall be adequately fenced to restrict access by unauthorized persons.
